## Have your Badge?

2) Or if you have a PDA or Smartphone, go to an Express Badge Pick-up kiosk and scan the barcode from your PDA/Smartphone for your badge to be printed.



## Things to Know...

- Create Your Schedule: Create a personalized schedule in advance by searching the Online Conference Planner at <u>www.nctm.org/planner</u> prior to coming to the conference. Search by grade band or topic and see if your favorite speaker is presenting. Please note that adding presentations to your personal schedule does not reserve you a seat. All presentations are open to conference participants and tickets are not required. Admission is on a first-come, first-served basis.

- Tax Exemption Status: If you plan to make a tax exempt purchase at the NCTM Bookstore, please be aware of NCTM's Sales Tax Policy for Bookstore Purchases. The state of Pennsylvania will only accept in-state Pennsylvania Tax Exemptions. To purchase your items as tax exempt you must present a copy of your Pennsylvania tax exempt status card or copy of your Tax Exempt Letter issued thru the Pennsylvania Board of Equalization at checkout. NCTM is required by law to keep a copy of the certificate, and we will be unable to return it to you. Out-of-state exemptions will not be accepted.
- **Cancellation Information:** If your request for a refund is received in writing by close of business on March 26, 2012 NCTM will refund fifty percent (50%) of your registration fee.
