




Universal Design for Learnig (UDL)

Universal Design for Learning (UDL) framework is gaining recognition internationally for its increasing presence across different educational literature and research studies from primary and post-secondary education to higher education.



Positive affects on students' persistence, retention, and satisfaction.

Objectives

- Identify the challenges of online teaching and learning during the COVID-19 from a learners' (stage 1) and from a teachers' (stage 2) perspective.
- 2. Propose and validate a **modular curriculum** (stage 3) and an **open repository of materials** (stage 4) for the creation of a **new professional profile** "Certified Trainer in Inclusive Distance Learning" (stage 5).



Challenges of online teaching and learning

- UDL remains unknown within the teaching community, very theoretical > Easy to understand guidelines.
- Need for guidance to understand, manage and promote diversity in online courses
 > Address user needs.
- Need for guidance to implement accessibility features and services of the given platforms > Guidance on provided ICT tools
